


MICROCAT®-ST Toilet/Septic Tank Deodorizer and Activator

Application Programs

In general, **MICROCAT-ST** is mixed with water and added directly to the commode, drain or trap. After tank pump out, add **MICROCAT-ST** to reestablish activity in the system.
